

# MEDIA RELEASE ENFORCEMENT OF VEHICLE ENTRY PERMIT (VEP) FROM 1 JULY 2025 AT THE MALAYSIA-SINGAPORE LAND BORDER

- 1. The enforcement of the Vehicle Entry Permit (VEP) at the Malaysia–Singapore land border began on 1 October 2024. This was implemented in phases, starting with an advocacy approach, whereby Reminder Notices were issued to owners of Singapore-registered vehicles who had yet to register for the VEP.
- 2. Based on this first phase of enforcement, a total of 52,012 Singaporean vehicles were randomly inspected, and 2,245 Reminder Notices (equivalent to 4.32%) were issued to vehicle owners who had not yet registered for a VEP.
- 3. As of 2 June 2025, the statistics for RFID tag installation involving privately owned individual and company vehicles are as follows:

- 4. To maintain road safety, the Malaysian Government will proceed with full enforcement of the VEP requirement starting 1 July 2025. From this date, summonses will be issued to foreign vehicle owners who have not registered or activated VEP.
- 5. This enforcement measure is in accordance with Section 66H(7) of the Road Transport Act 1987 (Act 333), which stipulates that it is an offence for any person to drive a foreign-registered motor vehicle into or within Malaysia without a valid permit.

6.	The enforcement procedures for foreign vehicles in relation to VEP registration	
	are as follows:	

Vehicle Type	Enforcement		
venicie type	Without Valid VEP	Pre-registered VEP	
Private Individual Vehicles	Summons issued; payment must be made and VEP registration must be done BEFORE exiting Malaysia.	Summons issued; payment must be made BEFORE exiting Malaysia.	
Private Company Vehicles	Summons issued; payment must be made and VEP registration must be done BEFORE exiting Malaysia.	Reminder Notice issued; vehicle allowed to exit Malaysia.	

7. Foreign vehicle owners issued with a summons for not having a valid VEP must settle the fine before exiting Malaysia. Summonses must be paid via cashless methods at Road Transport Department (JPJ) counters, JPJ Mobile counters, or online via MyEG.
